<p>As part of planning for step 4 of the government’s roadmap on the 19<sup>th</sup> July, it is a legal requirement that schools should review and update their risk assessments (building on the learning to date and the practices we have already developed), to consider the removal of restrictions and control measures in line with the roadmap out of the pandemic. We have reviewed and updated our wider risk assessments and considered the need for relevant revised controls in respect of their conventional risk profile considering the implications of coronavirus (COVID-19). We have ensured that we have implemented sensible and proportionate control measures which follow the health and safety hierarchy of controls to reduce the risk to the lowest reasonably practicable level.</p> <p>Guidance for step 4 schools. **Face Coverings:**

It is recommended Secondary schools now re-introduce face coverings in communal areas. Face coverings should also be worn by secondary school pupils on school transport. This recommendation has been sent to schools in a recent head teacher bulletin and signed off by Jane Moore (Director of Children Family Services) and Mike Sandys (Director of Public Health).

**Outbreak Management:**

From Step 4, close contacts will be identified via NHS Test and Trace. You may be contacted in exceptional cases to identify close contacts, as currently happens in managing other infectious diseases. You will continue to have a role in working with health protection teams in the case of a local outbreak  
Schools should ask parents and staff to inform them immediately of the results of a test: 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection'

**Domestic residential educational visits:**

Domestic residential educational visits In line with the roadmap, schools can undertake domestic residential education visits, from 17 May. Bubbles are no longer required after 19<sup>th</sup> July.

International visits can resume after 19<sup>th</sup> July but are not recommended until the autumn term.

Any domestic and international residential educational visits must be conducted in line with relevant COVID-19 guidance and regulations in place at that time and for the country you are visiting. For international trips the foreign and commonwealth office (FCO) should be consulted before any trip is considered.

For international visits school will need to be mindful of the restrictions still in place regarding the red, amber and green list and be mindful that for amber countries there may be requirements for all participants to quarantine or self-isolate upon return.




Schools will also need to be mindful to check their insurance status for short notice cancellation.





<b>Medium</b>	It is advised that further controls are implemented to reduce the risk rating to as low a level as possible. If the risk cannot be reduced to lower than a medium, then on site monitoring should occur to ensure that all stipulated controls are being adhered to.
<b>High</b>	This is an unacceptable risk rating. Urgent interim controls should be implemented to reduce the risk so far as is reasonably practicable. If the risk rating cannot be reduced to lower than a <b>High</b> , then a documented safe system of work should be implemented to control the activity. It may be necessary to seek further professional advice. Serious considerations should be given to the validity of carrying out the activity at all. Regular monitoring of the activity should occur.
